DESCRIPTION OF REQUIREMENTS

UNECA hereby seeks to pre-qualify a suitable contractor to refurbish and maintain the UN Conference Center (UNCC) flat roof covering approximately 5,000 m². The works include removal of the existing gravel ballasted roof with its pvc membrane, thermal insulation boards, drainage sheets, etc followed by installation of a new exposed roof water proofing systems as per the required specifications.

Interested contractors should:

- (i) Have relevant hands-on experience in the above-mentioned discipline.
- (ii) Have a technical team composed of a project manager, foreman and senior technician who have relevant mechanical and architectural knowledge related to the water proofing systems
- (iii) Be able to present a work plan that would ensure minimum disruption of activities of the UN Conference Center (UNCC)
- (iv) Be able to provide at least 15 years warranty period for materials to be supplied and one year warranty period for workmanship
- (v) State their envisaged completion time.

Only pre-qualified firms may be invited to the tender by a "Request for Proposal" (RFP).

Please note that the UNECA is precluded from entering into contract with a firm that is not fully registered with UNECA. Those interested in responding to this invitation but not currently fully registered as vendors with UNECA, are encouraged to register before submission of their offer. Your subsidiaries, agents, intermediaries and principals agree to cooperate with the United Nations Office of Internal Oversight Service during any investigative processes undertaken by them, either before during or after execution of a contract, including providing all required documents, company records, access to employees, officers and staff, as well as financial information.
