Tax Equity Initiative at IBP

Produced 4 broad knowledge products:

- Latin America Tax Expenditure Research, Analysis and Learning (LATERAL Project)
- Global CSO Scan
- 7 country case studies (types of CSOs advocacy)
- Literature review on the political economy of CSOs tax work players and processes

Tax Equity Initiative at IBP

Focus was:

- On providing support to 10 organisations in Latin America on research, capacity building and advocacy, peer learning, and linkages to regional actors and events (tax expenditure and inequality)
- An extensive scan of 171 organisations in 66 countries to understand CS approaches to tax work (what, how, where) and constraints they face in advocating for tax reforms
- Indepth case studies of successful tax reform campaigns around the globe entry points and modalities of the work
- On understanding the players, process and how these influence the process of tax reform

The LATERAL Project

The Africa Tax Equity Pilot Project

Innovative engagements with governments in Nigeria and Senegal to raise more revenues to fund the SDGs through an equitable, transparent, and gender responsive approach

- Strengthen capacity, knowledge and consciousness of non-state actors to influence tax systems
- Activate agency of people most affected by unfair tax system (women groups, BMOs, farmers, etc.)
- Facilitate shift in tax policy making towards equity
- Domestic tax issues; politically-smart and contextsensitive

What we are learning

Lessons from IBP's work

- Historically, regular citizens and civic actors play very limited role in formulation of tax policies.
- This is changing
 - DRM linked to funding of the SDGs
 - Efforts by INGOs in collaboration with other actors to get the rules of international taxation reformed
- Civic actors can propose and push for specific tax reforms or oppose reforms that had been introduced by the government.

Lessons from IBP's work

- The importance of narratives, messaging and media powerful, convincing, able to galvanise stakeholders
- Deploying the right strategy multiple strategies work best
- Building effective coalitions with allies
- Learning and building capacity technical capacity, political capacity, communications capacity (to learn and adapt)
- Leveraging political opportunities –windows of opportunity

Civic Actors and Voluntary Tax Compliance

CSOs and other civic actors can be:

- Translators (they are also experts!)
- Trainers (see above!)
- Enablers and facilitators of dialogue (they organise constituencies!)
