Session 5: Policy / Legal Frameworks for Digital Identity and Interoperability

- Objective
 - Explore and share experiences on policy, legal and regulatory frameworks required to realize inclusive Digital ID for all.
 - Develop globally interoperable identity system for African member states in accord with the AU Interoperability Framework for Digital ID
- Outcome
 - Member states developing robust policy, legal and regulatory frameworks for sustainable and interoperable Digital ID in Africa.

Session 8: Digital Payment & Financial Inclusion

• Objective

- Analyze the role of Digital ID for the uptake of Digital payment and financial inclusion within countries and for cross-border digital trade.
- Review the legal and regulatory framework necessary to boost Digital payment within and across borders.
- Share different initiatives taken by stakeholders to boost Digital ID for seamless digital payments.
- Outcome
 - Strengthening African legal and regulatory frameworks for Digital ID to boost Digital payment and financial inclusion.

Session 6 - The Nexus between Cybersecurity, Artificial Intelligence and Digital ID Systems in Africa

- Objectives:
 - Scrutinize how the continent can enhance the integration of cybersecurity considerations into digital ID related policies.
 - Review the implications of the rapidly evolving AI systems in relation to digital systems and cyber-related policies and
 - Analyze means to leverage Artificial Intelligence in Africa to achieve trust and security in the deployment of Digital ID initiatives
- Outcome
 - Member states analyzing the potential and challenges of emerging technologies to be considered during the designing and implementation of Digital ID systems in Africa

Session 7: Digital ID: A key to inclusive growth

- Objective
 - Learning from different initiatives that are taking place in the continent and around the globe including:
 - Prioritization framework implementation for Digital ID; the Case of Kaduna State, Nigeria
 - Digital Payments and its impact on Economy- a case of inclusive growth and extent of Digital payments,
 - Digital ID to enhance Cross-Border Digital Trust in Africa: Challenges and Opportunities:
- Outcome
 - Raising awareness among member states on the impact of Digital ID for sustainable and inclusive growth in their countries

Session 9: South - North partnership to develop a sustainable digital ID & interoperability
